issued from time to time.
2. That the school shall admit students without any  
discrimination of caste and creed.
3. That the school shall meet the additional liability  
of Secondary Classes.
4. That the school shall purchase adequate of Science  
Equipments and apparatus on par the norms of  
CBSE/Education Department for Secondary Classes.
5. That a proper library shall be established and  
facilities for reading-room shall also be made  
available for students as well as teachers.  
Books as per the ratio of 10 books per student.

- 6. That adequate sports material shall be purchased and made available to the students.
- 7. That the school shall strictly abide by the provisions of section 10(1) of the Delhi School Education Act-Rule 4, 1973.
- 8. That the school shall not run any unrecognised classes or any non-educational activities within the school premises and all the recognised classes shall be run at one place at the above address only. Nursery classes be removed from the premises of the school immediately, if any.
- 9. That the school shall dispense with the services of unqualified and over-aged staff, if any, immediately.
- 10. Fresh Health Certificate from MCH be obtained and produced to Education Officer for verification.
- 11. The management of the school will obtain land from EDA, if already not obtained, in the name of the society through Directorate of Education, Delhi and shall construct a school building thereon for the school as per specifications of the department within a period of 2 years. That adequate and sufficient accommodation of 12 sq.ft. per student shall provided for the class-room. The normal size of the class-room will 24' X 20'.
- 12. The Managing Committee of the school shall not increase/charges fee during the ongoing academic session without the prior approval of Director of Education which is a mandatory requirement under Sub-section (3) of section 1 of Delhi School Education Act, 1973.
- 13. That all the facilities prescribed under Rules 30 & 31 of the DSE, 1973 shall be made available to the students.
- 14. Xth Class should not be added without the prior approval of the Director of Education.
